

REGENERATION

INTRODUCTION

This is a period of unprecedented investment in Sandwell from both public and private sources.

The Regeneration Pipeline for the Borough covers a 5-year period between 2022 and 2027 and was approved by Cabinet in March 2022. The pipeline currently represents an estimated **investment value of £3 billion across 69 live projects.** This is across a wide range of sectors including education and skills, sustainability, health, transport, housing, digital, employment, town centres and heritage. Regeneration is about improving places and creating opportunities for everybody to prosper and participate in society e.g. having access to a home, skills and employment.

The Regeneration Pipeline delivers the long-term infrastructure and facilities for the Borough's residents. Flagship investments such as the **Midland Metropolitan University Hospital in Smethwick** (£700m), the

Wednesbury to Dudley metro extension (£450m), the Enfinium Energy from Waste Plant in West Bromwich (£500m), the Central St Michaels Sandwell Science. **Engineering and Manufacturing Centre in** West Bromwich (£5.2m) and the world class Sandwell Aquatics Centre in Smethwick (£92.25m) provides services to residents from Sandwell and the wider West Midlands for decades to come. However, this is not just about large construction projects, the Pipeline has seen the delivery of Urban Greening initiatives in West Bromwich Town Centre to enhance the existing greenspace and improve the appearance of the town and the delivery of the Green Roots Cultural Programme (Part of Urban Greening Project) including community involvement and artistic interpretation to help improve the physical and mental wellbeing of people. As a result of these projects, West Bromwich Town Centre has seen an increased footfall of 38.6%. There is also a significant

investment of an estimated £53m+ in Education and Skills at Primary, Secondary and Further Education levels across the Borough.

"Situated at the heart of the West Midlands, the time is now for Sandwell to show that it really is the destination of choice for people to live, visit, and do business. We want everyone to have fair and equal chances in life, and our Regeneration Pipeline will help to deliver a meaningful future for more people in Sandwell. Our diverse communities are passionate and ambitious, and we will do everything we can in supporting them to reach their potential. For this reason, we seek to maximise Social Value throughout our Regeneration Pipeline, and work with our partners to achieve this."

Just as importantly, this investment programme must benefit local businesses and residents through employment opportunities in construction, supply chain and apprenticeships. The Council is engaging businesses direct to signpost these opportunities in multiple ways. As one example, 70% of the entire project spend on the Wednesbury Health Centre at King Street, Wednesbury has occurred within a 15-mile radius of the site and supported 15 college students on site studying construction. A second example, 61% of the entire project spend on the Windsor Olympus Academy has occurred within a 10-mile radius of the site and has included significant employment and supply chain opportunities.

The Council continues to develop how to work effectively with key partners and contractors to ensure maximum value for the local economy. This includes the partnership we have with Sandwell's Anchor Institutions, through Sandwell's Anchor Network. There is also the important challenge of how the Borough delivers against its low carbon / climate change strategy as part of this Regeneration Pipeline to identify practical ways in which this policy commitment can be delivered. This prospectus provides an overview of progress in Year 2 (2023/24) of the five-year programme and identifies what has yet to be delivered.

for Regeneration Pipeline

There are a wide variety of funding sources that support the delivery of the Regeneration Pipeline.

The Council actively engages with multiple funding bodies to secure resources. It is important that the Borough can attract private investment as well as public investment as a mix of the two is more sustainable in the medium to long term. In some cases, public funds can unlock opportunities for private investment. Most Regeneration Pipeline schemes are delivered by the private sector even where funded 100% by public funds so it is important that the Council maintains strong working relationships with these key delivery partners.

Here are some examples of the types of investment secured already: -

- NHS (national and local level) New Acute Hospital.
- Enfinium private investment in new Energy from Waste Plant (2022).

- Wednesbury to Dudley (Phase 1) Metro Extension (Department for Transport and WMCA).

- Programme for Full Fibre connectivity in Sandwell - Private Investment
- City Region Sustainable Transport Settlement (CRSTS) – DfT funding channelled via the Combined Authority.
- Department for Education funding for four new schools in the Borough.
- Department for Culture, Media and Sport funding contribution for Aquatics Centre.
- Department for Levelling Up, Housing and Communities (DLUHC).
 - Towns Fund programme of 16 schemes (£67.5m) June 2022.

- Delivered Sandwell Aquatics 'Legacy Construction Phase 3' and opened the doors for public to use the new leisure facility in July 2023.
- Delivery of a new 900 place Windsor Olympus Academy in Smethwick, that welcomed its first set of students in September 2023.
- Completed the extension to the Ron Davis Adult Education Centre to facilitate additional activities, with 101 new learners enrolled to date

Due to handover and complete all 114 affordable units in 2024 with 30 completions to date.
- Demolition of the former Langley Baths site to make way for new Affordable Housing.

- Procurement process commenced to appoint a Delivery Partner for the Friar Park Urban Village to regenerate major brownfield site with 630 new homes.



- Feasibility study and option appraisal complete for decongestion at J1 of the M5. Options being evaluated by Sandwell Council and Black Country team to determine next steps.
- Supported Combined Authority led transport schemes that support Sandwell including the Smethwick to Birmingham Corridor, Dudley Port Transport Hub and SPRINT.

- Directly participated in the Wednesbury to Dudley (Phase 1) Metro extension Project Board with WMCA and Dudley MBC.
- £40m investment programme in Sandwell by BT Open Reach. 77,000 Full Fibre Built to date with 26,000 built in the last 18 months and a further 40,000 planned.
- £30m investment programme by Netomnia for a full fibre network to future-proof the infrastructure in Sandwell. Phase 1 is complete connecting 9,126 resident and business premises with Ready for Service (RFS). Phase 2a will take place during May and June 2024 and will include 5,500 connections and Phase 2b will take place during July and August 2024 and will include 4,332 connections.
