The companies included in the Top 50 Fastest Growing Companies 2023 were selected in partnership with The Economic Intelligence Unit (The EIU) by conducting an initial search of relevant business databases (FAME, DueDil and The Data City) for companies with registered offices in Sandwell. The fastest growing 50 companies by turnover were listed based on the most recent filed accounts and utilising the turnover growth rate in the latest year of individual company accounts. The current year's financial information is based on the most recent filed accounts from the listed business databases, with the previous year comparatives based on the previous year's financial results for 50 companies. Companies were excluded from the development lists for the following reasons (while some adjustments were also made to reflect financial volatility around the years of Covid-19

- No 'real' turnover data available since 30 June 2020/21
- Negative growth recorded over the last two available years
 Last annual turnover available less than £1m
- No 'real' current employment data
 Last available number of employees less than ten
- · A parent company based in Sandwell that is: only the largest company in a group would

Attributes growth to: A strategic acquisition streamlined operations, and strong national and European Market Expansiont

GB Tyres (UK) Limited is the UK's largest independent wholesaler of commercial tyres. Over the past year, the company has achieved exceptional revenue growth, driven by a bold acquisition and a focus on operational excellence.

In September 2024, GB Tyres acquired a small Scottish competitor operating in the agricultural tyre sector. Following the purchase, the business was restructured, supplier terms renegotiated, and new cross-selling opportunities created between commercial and agricultural customers.

As a result, the acquired business was tranformed from underperformance to sustained profitability, while significantly boosting group revenue. GB Tyres' continued success is underpinned by its national customer base, application of lean management principles, and the purchasing power gained through economies of scale. Together, these strengths have reinforced the company's position as a leading distributor in the UK tyre industry.



Looking ahead, GB Tyres plans to double sales within the next 18–24 months, supported by growth in the European market. Already exporting £7 million of tyres into the EU, the company believes there is significant potential for expansion as post-Brexit trade stabilises.

Sandwell remains the company's launchpad for growth. With excellent transport connectivity and a skilled local workforce steeped in automotive expertise, GB Tyres continues to invest in the borough. Support from Sandwell Business Growth has provided valuable local knowledge and encouragement as the company pursues its next phase of expansion.

Attributes growth to: A strategic diversification continous investment in innovation and a commitment to developing skilled talent

A&M EDM provides precision-engineered solutions by combining EDM spark and wire erosion, CNC milling and turning, and toolmaking. Its agility and innovation enable it to design and manufacture components for customers in aerospace, automotive, Formula 1, food production, marine, production assembly and space sectors.

The company's turnover has risen from £4.4m in 2021 to a projected £10m by the end of September 2025. This sustained growth reflects a clear three-year business plan and consistent investment in people, technology, and customer relationships.

Over the past five years, A&M has upgraded 20 EDM machines and invested over £4 million in advanced CNC equipment, solar panels and digital production systems. Its new QuickWorks MRP system allows real-time monitoring and workflow optimisation, increasing efficiency across its 85-strong workforce, which includes 11 apprentices.

In 2023, the company completed a Midlands Aerospace R&D project, supported by a £103,000 grant, to design a concept 20hp engine. This innovation evolved into the Ranger propulsion system, featuring a class-leading power-to-weight ratio for UAV applications. The project has positioned A&M as a serious player in emerging defence technologies.



A&M's growth has also been driven by expanding into new sectors, including supplying four Formula 1 teams, developing long-term aerospace contracts worth over £1m annually, and entering the fastener tooling market to serve global manufacturers.

Supported by Sandwell Council through a £62,000 SME grant for new machinery and environmental guidance, A&M continues to champion local growth and sustainability. The company also invests heavily in staff wellbeing, introducing private health insurance, mental health support and a new staff gym and golf simulator opened in June 2025 by Smethwick MP Gurinder Josan.

Backed by Sandwell Council's Business Growth Team, the Hub is more than a workspace, it's a community. It brings together ambition, innovation and local pride in an environment designed to help new businesses succeed. Any Sandwell-based company trading for less than two years can use the space free of charge until March 2026.

A space designed for success

Located in Jack Judge House (B69 2AJ), opposite Sandwell Council House, the Hub is open Monday to Friday, 9am to 5pm. It offers:

- •60 hot desks in a modern, open-plan office
- •Collaborative areas for networking and idea sharing
- •Quiet zones for focused work
- Meeting rooms and kitchen facilities
- •Free Wi-Fi and nearby parking (three hours free at Sainsbury's)

Investing money in the area – by subcontracting locally or using local suppliers; by investing in buildings and spaces

3. Community benefit and engagement Giving support, guidance, time or resources to non-corporate organisations such as schools, colleges, community groups and charities in the borough

4. Environmental impact

Bringing environmental benefits by reducing, reusing or recycling physical resources; reducing carbon output; reducing the amount of waste sent to landfill; reducing energy consumption.

Hall of fame

Since 2015, over 219 outstanding businesses have earned their place in the Sandwell Top 50 report, a powerful testament to the depth, resilience and ambition of our local economy.
